Lipid Profile and Hematological Assessment of Ethanol Extract of Whole Merremicae hederacea in Rats

ABSTRACT

Immunological competence plays an important role in the progression of illness and treatment of diseases. The pathology of many diseases is associated with inflammatory responses. HDL-cholesterol is a potent anti-inflammatory agent known to reverse cholesterol transport from the arteries back to the liver for detoxification. The aim of this research was to evaluate the hypolipidaemic and immunomodulatory potentials of Merremicae hederacea. Crude Ethanol extract of Merremicae hederacea whole plant was administered to Wister rats daily over 4 weeks while the control group received normal saline. 3 rats were randomly selected from each group and sacrificed. Blood samples were collected for lipid profile and haematological analyses respectively. Cholesterol, triacylglycerol, HDL and LDL cholesterols were determined. Blood indices such as haemoglobin, haematocrit, red blood cell distribution width, red blood cell, white blood cell, lymphocyte, monocyte and granulocyte counts were determined. M. hederacea extract was able to significantly (p > 0.05) increase HDLcholesterol concentration of the test compared to the control and also decreased significantly (p > 0.05) LDL-cholesterol concentration compared to the control There was no significant (p < 0.05) difference in both white blood cell and red blood indices of the test compared to the control, however, there was a significant (p > 0.05) difference in the G/AG ratio of the test group compared to the control, thereby increasing chances of immune stimulation. M. hederacea extract has ability to increase serum HDL cholesterol levels and also stimulate the immune system. This outcome could not only potentially reduce the morbidity and mortality associated with cardiovascular diseases but also provide incentive for the development of a range of therapeutic agents designed specifically to increase HDL levels.

INTRODUCTION

Derangement in normal serum lipid profile has been the cause of many illness and life threatening diseases. Diabetes mellitus, hypothyroidism, nephrotic syndrome, hypercholesterolemia, renal disease, obstructive disease, dysproteinemias atherosclerosis are examples of such diseases and disorders that could result in abnormal serum lipid (Shabana et al., 2020). Inflammation within the atherosclerotic plaque plays a major role in plaque rupture and the occurrence of acute coronary events (Bulbul et al., 2018). medications, Some such as estrogens, progestins, androgens, retinoids, corticosteroids, beta-blockers, cyclosporin A, phenothiazines, anticonvulsants, diuretics, and certain antiviral agents are also known to modulate serum lipids (Osuji et al., 2012 and Ames, 2012).

The primary role of immune system is to protect against infection/foreign invasion. Other roles

including tissue repair, wound healing, elimination of dead and cancer cells, and formation of the healthy gut microbiota are important contributions of the immune system (Simon et al, 2015). Lymphocytes proliferate and differentiate at exponential rate, to maximize fighting power against antigen, resulting in the death of the majority of antigenspecific lymphocytes involved in the immune response. The few lymphocytes that survive become long-lived memory cells, which ensure that a second encounter with the same antigen is dealt with swiftly and effectively, due to the advantages they have over their naive predecessors in terms of their greater number, extended lifespan, more rapid response rate, superior proliferation capacity, and wider access to tissues (Yatim and Lakkis,

Immunological competence plays an important role in the progression of illness and treatment of diseases (Liu and Wei, 2010). The pathology of manv diseases is associated inflammatory responses. Inflammation is a defensive process initiated by the immune system against harmful stimuli (such as pathogen, damaged cells and toxic compounds) and acts by removing injurious stimuli and initiating repair or causing pathogenesis if unchecked (Hipp et al., 2017). Although inflammatory response depends on the nature and location of the stimulus, the mechanism remains the same, which includes cell surface pattern receptor recognition, activation of inflammatory pathways, released recruitment of inflammatory markers (Chen et al., 2017). HDL-cholesterol is a potent antiagent inflammatory known to cholesterol transport from the peripheral vessels back to the liver for detoxification (Kosmas et al., 2019). HDL produces anti-inflammatory effects in lesion macrophages suggesting a beneficial therapeutic effect of HDL in vivo (Fotakis et al., 2019).

Green flora has remained the source of bioactive compound for the treatment and management of diseases in Africa since time immemorial. This has caught the global attraction towards natural product drug discovery for newer, safer and affordable medicine (Swargiary, Although in most cases no scientific studies have been done to prove the efficacy of these medicinal plants. Merremicae hederacea (Burm.f) Hallier is an herbaceous, glabrous twiner and climber, belonging to the family of convolulaceae (Akobundu et al., 2016). It is a medicinal plant common to riverine forest and grassland, often grown on sandy soil and it is distributed in Africa, Tropical Asia and Australia (Simoes et al., 2015). The leaves are simple, ovate, 1.5-5cm long and 1.5-4cm wide (Charles et al., 2012). The fruits are globoid or broadly conical capsules, indistinctive 4-angled, valves (Akobundu et al., 2016). The seeds are pubescent or glabrous and 2.5mm long (Charles et al., 2012). It is also used as a detergent by dwellers of riverine area in Africa before the advent of soap and the beautiful flowers are cultivated as ornamental plants. Merremicae hederacea is used locally for the treatment of fever. Grounded leaves mixed with turmeric are used to cure wounds and as an antiinflammatory agent (Simoes et al., 2015). Despite the anti-inflammatory properties of this plant, scientific reports on its medicinal properties are few. The aim of this research was to evaluate the hypolipidaemic and immunomodulatory potentials of this plant.

METHODOLOGY

Collection and Extraction of Merremicae hederacea Plant

Merremicae hederacea was collected from Wuya in Lavun local government area of Niger State. Taxonomic identification authentication was performed at the National Institute for Pharmaceutical Research and Development (NIPRD), Idu- Abuja, where voucher specimens (NIPRD/H/6914) was deposited. The whole plant was air dried at room temperature and pulverized. 500 g of the pulverized sample was extracted with ethanol under reflux for 2 hrs. The filtrate was concentrated on a water bath and the solvent was completely evaporated in a fume cupboard to obtain the crude extract and then stored under refrigeration until required.

Animals Used

Healthy Wister rats in the range of 120-140g of either sex were obtained from Ahmadu Bello University Zaria, Nigeria. Ethical approval was obtained from Committee on Ethics for Medical and Scientific Research of Federal University of Technology, Minna, where the research was conducted. The principles, governing the use of laboratory animals as laid down by the Committee and also internationally accepted principles for use and care of laboratory animal as contained in the Canadian Council on Animal Care Guidelines and Protocol Review and international standard (1985) were adhered to. Twenty-four Wister rats were grouped into two groups of 12 rats each. The test group was given 200mg/kg of Merremicae hederacea crude extract while the control group received 0.1 mL of physiological saline daily for 4 weeks. The animals had access to pelleted feed and water ad libitum. On weekly basis, 3 rats were randomly selected from each group and sacrificed after overnight fast. Blood samples were collected in plain and heparinised bottle for estimation of lipid profile and haematological parameters respectively.

Lipid profile and Hematological assessment of *Merremicae hederacea* extract in rats

Moisture content of samples was determined by Randox diagnostic kits and a double beam UV visible spectrophotometer (Ebra Chem5v3 model) were used for the estimation of cholesterol, triacylglyceride (TAG), and high density lipoprotein (HDL), according to the methods of Thomas *et al.* (1998), Tietz (1990)

and Jacobs *et al.*, (1990) respectively, while low density lipoprotein(LDL) was obtained using the formula:

The hematological parameters were determined using heparinised blood samples with the aid of hematological analyser, Abacus 380.

Statistical Analysis

Results were analyzed using one-way ANOVA, with Statistical package MINITAB version 14. The results are expressed as mean \pm Standard error of mean ($\bar{x}\pm SEM$) of triplicates. Values with the same superscript are significantly (p<0.05) same while those with different superscript are significantly (p>0.05) different along the column.

RESULTS

Percentage yield of the crude extract of *M. hederacea* was 2.57 %.

Lipid profile of rat administered ethanol extract of M. hederacea for 28 days compared to the control is presented in Table 1. There was no significant (p < 0.05) difference in the total cholesterol and triacylglycerol concentration over the four weeks period. However, HDL concentration of test group were significantly (p

> 0.05) higher compared to control throughout the experimental period while LDL concentrations of the test group decreased significantly (p > 0.05) compared to the control.

Table 2 represent the white blood cell components of rats administered *M. hederacea* extract compared to the control over the period of four weeks. There was no significant difference in total leucocyte, lymphocyte, monocyte and granulocyte counts of the test group compared to the control. However, the granulocyte agranulocyte ratio was significantly higher compared to the control group.

The red blood cell indices of rats administered *M. hederacea* extract compared to the control is represented in Table 3. There was no significant difference in RBC count, hemoglobin count, hematocrit and red blood cell distribution width of the test group compared to the control.

DISCUSSION

The significant increase in HDL cholesterol level and a corresponding decrease in LDL cholesterol of the test group compared to the control throughout the study period could be due to the effect of the extract Medication and nutrition have been reported to influence HDL composition (Bililoni et al., 2016). Studies have shown that dietary cholesterol increased serum and LDL cholesterols but triacylglyceride concentration (Berger et al., 2015). Dietary cholesterol is the culprit implicated in the increased blood cholesterol levels leading to elevated risk of cardiovascular diseases (Soliman, 2018). LDL cholesterol and high blood pressure are risk factors for development of coronary heart disease (Ueda et al., 2018). This study shows the absence of dyslipidaemia. Dyslipidaemia is characterized with total cholesterol \geq 5.2, LDL cholesterol \geq 3.8, HDL cholesterol < 0.9 and TAG \geq 1.58(mmol/L (Antwi-Baffour et al., 2018). The HDL increasing property. implies that M. hederacea has the ability to reverse cholesterol transport, decrease the risk of fatty acid deposit in the blood vessels, reduce the chances of arthrosclerosis development and damage to blood vessels as well as improve metabolic health The anti-inflammatory, cytoprotective and wound healing effects of HDL cholesterol which makes it a part of the innate host defense

system (Adams *et al.*, 2013 and Marz *et al.*, 2017) also implies that *M. hederacea* extract could enhance rapid healing of wound.

Although HDL has both anti-inflammatory and proinflammatory effects, the anti-inflammatory effect predominates over proinflammatory potential during inflammation. The antiinflammatory effects of HDL-cholesterol are associated with reduced TLR (Toll-like receptor) 4 levels and reduced interferon receptor signaling while the proinflammatory effects occurs under conditions of extreme cholesterol depletion through a modified endoplasmic reticulum stress response that involves IRE1a (inositol-requiring enzyme 1a)/ASK1 (apoptosis signal-regulating kinase 1)/p38 MAPK (p38 mitogen-activated pro- tein kinase) signaling (Fotakis et al., 2019). The antiathrosclererotic properties of HDL are likely the results of multifunction fulfilled by HDL including antioxidant; anti-inflammatory, antithrombotic and vaso regulatory actions in addition to its established ability to promote reverse cholesterol transport (Berthet et al., 2014). Inflammation is a common pathogenesis of many diseases including malaria, typhoid, diabetes, arthritis, cancer, cardiovascular and bowel diseases (Chen et al., 2017). Therefore, substance with anti-inflammatory property will have overwhelming effect on these diseases. Strategies that increased HDL levels could potentially decrease the incidence cardiovascular disease (Rye, 2013). This upshot could not only potentially reduce the morbidity and mortality associated with cardiovascular and inflammatory diseases but also provide incentive for the development of a range of therapeutic agents designed specifically to increase HDL levels.

M. hederacea extract has ability to maintain a steady immune system by maintaining total leucocyte (white blood cell), lymphocyte, monocyte and granulocyte counts of the test group compared to the control group, while increasing immune system response potential by increasing in granulocytes agranulocytes ratio of the test compared to the control group, thereby enhancing the immune response potential in case of system against foreign invader. It will be expected that this extract should have an immune stimulating potential due to its high saponin concentration (Sulaiman, 2021). Saponins are used in immune system stimulation in patients with low immunity (Nurain et al.,

2017). WBC counts can be regarded as a marker of an increased synthesis of cytokines, acute phase reactants and the activation of the inflammatory signalling network involved in the pathogenesis of diseases (Babio *et al.*, 2013). Increase in total leukocytes, lymphocytes and neutrophils have a positive association with hypertriglyceridemia and low HDL levels (Shankar, *et al*, 2004). However, in this study the extract was able to maintain total leucocyte count and also increase HDL cholesterol of the test group compared to the control.

Blood components such as white blood cells (WBC), granulocytes: agranulocyte ratio (G: AG), RBC and HGB are very significant, as they are essentially important parameters of the body's defense system. Although, the increase in granulocyte count was not significant in this study, people with low level of granulocytes are prone to infection (Deng et al., 2016). Any substance capable of increasing these blood parameters can stimulate immune system (Chatterjee, et al., 2013). Activated neutrophil can release reactive oxygen species (ROS) which attack invading microorganisms and the activated neutrophil undergo degranulation (Boly et al., 2015), a cellular process that releases antimicrobial cytotoxic molecules from secretory vesicles (granules) found inside some cells. It is used by several immune cells, including granulocytes (neutrophils, basophils, and eosinophils) and mast cells (Sheshalam et al., 2014).

The immune stabilizing potential is also evident by the lack of significant difference in total number of red blood cell (RBC), mean haemoglobin concentration (HGB), hematocrit and red blood cell distribution width (RBWC). Red blood cell possesses a unique role as gas carrier between blood and tissue. This function is altered in pathologic condition such as malaria. sickle cell anemia. diabetics. myocardial infarction and paroxysmal nocturnal hemoglobin (Tomaiuolo, 2014). Hemoglobin concentration and hematocrit are two parameters used to assess oxygen carrying capacity of the blood, to either diagnose anemia polycythemia. Oxygen transport is the most important function of hemoglobin in the red blood cells and oxygen affinity has a positive correlation with hemoglobin concentration (Di Caprio et al., 2015). Since administration of M. hederacea extract had no significant effect on both hemoglobin concentration and hematocrit

of the test group compared to the control, administration of M. hederacea extract will not hinder oxygen transport. Similarly, red blood cell characteristics are used to monitor and diagnose a wide range of conditions including malnutrition, inflammation and cancer (Malka et al., 2014). The RBWC is one of such that was unaffected characteristics administration of M. hederacea extract in this study. The observed stability in RBC count is an evidence to show M. hederacea extract will not have a negative impact on RBC count when explore for its therapeutic purposes in the treatment of illness that causes anemia, of which malaria, diabetics are inclusive.

Conclusion

M. hederacea extract has the ability to increase serum HDL cholesterol levels and also stimulate the immune system. This outcome could not only potentially reduce the morbidity and with mortality associated cardiovascular diseases but also provide incentive for the development of a range of therapeutic agents designed specifically to increase HDL levels and boost the animal immune responses.
