# Phytochemical, Heavy Metal Analysis and Phytotoxic Activities of Crude Extract of Annona senegalensis Stem Bark

# ABSTRACT

The phytochemical, heavy metals analysis and phytotoxic activities of Annona senegalensis extracts was determined. The fresh stem bark of A. senegalensis was collected, dried under air at room temperature, pounded into a powder and extracted by serial extraction. The Phytochemical screening was conducted, the concentrations of ten (10) heavy metals in A. senegalensis stem bark extracts were evaluated by atomic absorption spectroscopy (AAS) while the phytotoxic activity was studied using radish seeds in various concentrations of A. senegalensis stem bark (1000, 500, 250 and 125mg/mL). The result indicates that alkaloids, flavonoids, saponins and tannins, glycosides, terpenoids and anthraquinones were detected while Steroids were not detected. Heavy metals analysis showed that the concentrations of Pb, Mg, Mn, Fe, Zn, Cu, Ca, Ni, Hg and Cd were 3.03±0.01, 289.86±2.51, 44.03±0.99, 12.89±0.36, 30.48±0.03, 5.29±0.07, 88.78±2.01, 0.63±0.05, 0.02±0.01 and 0.07±0.03 respectively which were all below maximum permissible levels set by different standard organizations like WHO, FAO and FDA. For the phytotoxic activities, the result shows that the root and shoot lengths of the crude methanol extracts were generally higher than the control. However, there was higher % seed inhibition in the different concentrations of the crude methanol extracts (66.67%, 53.33%, 46.67%, and 80.00%), unlike the control which had only 40.00% seed inhibition. These results have proven the medicinal significances of A. senegalensis and a promising plant product based natural herbicides.

## **INTRODUCTION**

Nigeria is naturally blessed with an abundance of natural resources due to its different environmental conditions. The phytochemicals derived from these are been utilized by humans for sustaining their good health(Ahmad et al., 2014). These phytochemicals derived from plants are been used in pharmaceutical discoverysince past century. Various numbers of effectivedrugs have been manufactures, but traditional medication is adopted in many developing countries (Ahmad et al., 2014). Almost 80% of therapies from primary health care are coming from natural plantsall overthe world (Abbasi et al., 2010). Therefore, the utilization of the therapeutic efficacyof these plants to gain new novel, cheapest, effective and safer phytodrugs is very vital (Moghadamtousi et al., 2015). One such natural source with higher therapeutic efficacy is A. senegalensis.

Phytochemicals are classified into two groups, known as primary and secondary metabolites.The common sugars, amino acids, proteins and chlorophyll are the primary metabolites whereas the phenolic compounds, alkaloids, flavonoids, essential oils, saponins, terpenoids and tannins are the secondary metabolites (Krishnaiah *et al.*, 2009). Almost all thebioactive compounds in plants are designated to possess high therapeutic potential, which make the plants to possess their medicinal significance due to such phytochemicals in them (Price *et al.*, 1988).

Recently, researchers have shown increasing interest in phytotoxic medicinal plants (Wang *et al.*, 2013; Yang *et al.*, 2012). These could be as a result of the easier screening process of phytotoxic plants from medicinal plants (Chevallier, 1996), (ii) the ability to have more phytochemicals in medicinal plants.Some of these medicinal plantsare used in many forms to

Received 19 May, 2020 Accepted 4 July, 2020 Address Correspondence to: <u>yndatsu2011@gmail.com</u> managed weeds, e.g. (i) transplanting the weeds as cover crops to main crops, (ii) as bioherbicides by applying the plant extracts, or (iii) using theiractive substances to develop new bioherbicidal upon isolation and characterization (Islam and Hisashi, 2014).

Annona senegalensis (Wild Custard Apple or Wild Soursop) is a small tree with about 2-6 m in height. The species is habitat around river banks, fallow land, forests(Orwaet al., 2009). The plant is highly distributed in Northern Nigeria, especially, Nasarawa, Kaduna, Kano, Plateau, Niger States and also Federal Capital Territory, Abuja. The plant is popularly known as Numgbere in Nupe (Mustapha, 2013).All parts of A. senegalensis plant have been found useful for traditional medicine applications. The leaves of the plant are been used by traditional herbalists to treat yellow fever, tuberculosis, and smallpox (Aiyeloja & Bello, 2006; Mustapha & Uthman, 2013) whereas the stem bark has been used in treating snakebite and hernia (Dambatta & Aliyu, 2011). The ailments like; difficulty in swallowing, gastritis, snake bites, male sexual impotence, erectile dysfunction, tuberculosis, and anantidote for necrotizing toxins are treated by herbalists using the root bark (Ofukwu & Ayoola, 2008; Noumi & Afiatou, 2015; Jiofack et al., 2009). The treatment of chickenpox is effective using juice from tree (Faleyimu &Akinyemi, 2010; Ahomboet al., 2012).

Apart from ethnomedicinal uses of *A*. *senegalensis*, it serves as food and food additives. The leaves can be prepared as vegetables. In Nigeria and Tanzania, the uses of A. senegalensis as pest control have been demonstrated (Igoli *et al.*, 2005; Innocent *et al.*, 2014). The application of spread of fresh leaves on the floor of poultry houses until dried for the control of fleas and lice have been adopted in the Republic of Benin (Salifou *et al.*, 2012).

The works on phytochemical and biological activities of medicinal plants have been reported, but only little information as regard tothe heavy metal concentrations in the medicinal plants and herbal drugs have demonstrated (Karayil & Vivek, 2014).The presence of toxic metals (Nickel, Lead, Cadmium, Manganese and Mercury) in herbs can cause health risks (Peter & Smet, 2002).The trace concentrations of heavy metals in the soil and plants growing on it face some heavy metal stress and causes changes in the production of

secondary metabolites. High levels of heavy metal contamination inmedicinal or other plants may suppress secondary metabolite production. It is essential to maintain safetyquality and efficacy of the plants and their products to avoid serious health problems (Karayil & Vivek, 2014).

World Health Organization (WHO) recommends that such products must be evaluated for the extent of heavy metals and phytotoxic potentials before use in human beings (Ayaz *et al.*, 2014). Thus, according to these backgrounds of *A. senegalensis* multimedicinal uses, the present study was conducted to evaluate specifically stem bark methanol extracts for phytochemical and heavy metal analysis and its phytotoxic properties.

### METHODOLOGY

#### Chemicals

Paraquat (a positive control) in the phytotoxic assay was purchased from Sigma-Aldrich EC 231-791-2 and other chemical (Methanol) were analytical grade

#### **Collection of Sample**

The *A. senegalensis* stem bark was identified, harvested, and collectedin Lapai town environs, Lapai Local Government, Niger State, Nigeria on May 2019. It was reidentified and authenticated in the Biological SciencesDepartment, Ibrahim Badamasi Babangida University, Lapai, Niger State, Nigeria.

#### **Preparation of plant materials**

The *A. senegalensis*stem bark collected was washed to remove dirties using water, air dried at room temperature, pounded in to powder, weighed, kept in a plastic bagsand stored at  $\pm 4$  °C.

#### Extraction Method

From the dried sample (powder) prepared, treatment extract was produced. Briefly, fifty (50 g) grams of measured sample powder was soaked and shaken independently in 500 mL of 70% (v/v) methanol for 2 daysat room temperature. This was repeated three times and filteredusing filter paper (Number 2, Advantec Toyo Roshi Kaisha, Ltd., Tokyo, Japan). Thedried and concentrated filtratewas obtained at 40°C through dryness by a rotary evaporator (Heidolph Laborota 4000, Schwabach,

Germany). The filtrate was resuspended in methanolto producea 50 mg/ml crude stock fraction(Islam and Hasashi, 2014). The working concentrations (1000, 500, 250, 125 and 0 mg/mL) were prepared by further dilution of crude stock fraction.

#### **Phytochemical Analysis**

Qualitative phytochemical assay in plant extracts was performed using previous method of Meriga et al. (2012) to ascertain the presence of bioactive components (alkaloids, flavonoids, glycosides, anthraquinones, saponins, terpenoids, sterols and tannins).The Dragendorff's reagent was used to confirm the presence of Alkaloids, steroids and triterpenoids were assessed using Liebermann Burchard test. The "Keller Killian" Test was performed for the presence of glycosides. A few drops of glacial acetic acid and Ferric chloride solution were added and properly mixed up. In the mixture. a few drops of concentrated H<sub>2</sub>SO<sub>4</sub> were added and the formation of two layers was observed. A reddish-brown and acetic acid at the lower and upper layer, respectively, that turns bluish-green signifies the presence glycosides. Saponins detection was assessed following the formation of froth after vigorous shaking using diluted samples. The presence of Anthraquinones wasconducted by boiling the test sample with 1 ml of H<sub>2</sub>SO<sub>4</sub> in a test tube and then filter. Allow the filtrate to cooled and shacked with an equal volume of chloroform and dilute ammonia until the lower layer was separated. The formation of rose-pink to red color ammonical layer signifies the presence of anthraquinone glycosides. The presence of tannins was detected by treating The test sample with gelatin solution. The appearance of white precipitate signifies the existence of tannins.

### **Heavy Metals Analysis**

For heavy metal analysis, the methanol extract was prepared using graded chemicals.Briefly, 2 g of sample stock fraction was taken in a crucible and ignitedat 550°C for 6 hrsusing muffle furnace. In 5 mL of conc.  $H_2SO_4$ , the ash from crucible was digested, evaporated on a hot plate and in to digested residue, 1 mL of distilled water was added. The mixture was filtered, volume raised to 30 ml using distilled water and the resulted solution was analyzedusing atomic absorption spectrophotometer (model 1100; Perkin Elmer, Waltham, Massachusetts, USA) to read the presence of heavy metals such as iron (Fe), lead (Pb), zinc (Zn), manganese (Mn), magnesium (Mg), copper (Cu), calcium (Ca), nickel (Ni), mercury (Hg) and cadmium (Cd) (Akram et al., 2015, Aberaet al 2015).

#### **Determination of Phytotoxic Activity**

Phytotoxic effects were evaluated based on bioassay diaspore germination and early growth of seedlings. The radish seed (Raphanus sativus L. was used as the target species.

#### **Germination Bioassay**

This was carried out in petri dishes of 90 mm diameter containing two filter papers welted with 5 mL of methanolas plate 1 (negative control). The same volume of various working concentrations (1000, 500, 250, 125 mg/mL) of the extracts obtained from the powder of *A.* senegalensis stem bark with 25 radish seeds per

petri dish were placed at sufficient distance using sterilized forceps as plate 2, 3, 4 and 5, respectively, (treatment plates). All treatments and control plates were replicated three times, and the dishes were capped and sealed with plastic film. Completely randomized treatment was used as the experimental design. At 0.5 days to day-4 (time no further germination occurred and radical emerges), the germination was examined (Islam Hisachi and (2014).Othergermination indices measured include the average root and shoot lengths and number of seeds inhibition(Zebet al., 2014). After 5 days of incubation of all plates at 25°C in dim light, the following germination indices (number of seeds germinated and percent inhibition of root and shoot lengths) were calculated using formula:

## Data Analysis

All data recorded were analyzed using Analysis of Variance (ANOVA). The separation of meansat a 95% confidence interval (p<0.05) was performed using Duncan Multiple Range Test (DMRT).

## RESULTS

The Phytochemical present in *A.* senegalensis extracts are shown in table 1. Alkaloids, flavonoid, phenols, and tannins, Saponins, glycoside, anthraquinone, and terpenoids were detected in *A. senegalensis*  extracts, but steroids were not detected (Table 2).

The concentrations of heavy metals found in the crude powder of A. senegalensis stem bark are presented in table 3. The results show that the concentrations of Pb, Mg, Mn, Fe, Zn, Cu, Ca, Ni, Hg, and Cd were 289.86±2.51, 3.03±0.01. 44.03±0.99, 12.89±0.36.  $30.48 \pm 0.03$ . 5.29±0.07. 88.78±2.01, 0.63±0.05, 0.02±0.01, and  $0.07\pm0.03$  respectively. All the values were below maximum permissible levels of the respective heavy metals in medicinal herbs/products as set by different standard organizations like World Health Organization (WHO). Food and Agricultural Organization (FAO) and Federal Drug Administration (FDA).

The results of the phytotoxic effect of A. senegalensis stem bark extracts are shown in Table 4. It reveals that the root and shoot lengths of the crude methanol extracts were generally higher than the control. However, there was higher % seed inhibition in the different concentrations of the crude (66.67%. methanol extracts 53.33%. 46.67%, and 80.00%), unlike the control which had only 40.00% seed inhibition. More so, there was a statistically significant difference (p<0.05) in the results for shoot lengths, unlike the root length that was not.

#### DISCUSSION

The present of phytochemicals; alkaloids, flavonoid, phenols, and tannins, Saponins, glycoside, anthraquinone, and terpenoids in A. senegalensis extracts could signify it medicinal potentials as acclaimed by traditional herbalists in the treatment/management of various ailments associated with oxidative stress (Table 2). The medicinal values of these phytochemicals in the management of ailments such as diabetes, microbial Atherosclerosis, diseases. cancer and inflammatory diseases have been reported (Chukwuka et al., 2011; Ruffo et al., 2002). Different portion extracts of A. senegalensis can be used to manage diseases such as anaemia, gonorrhea, dysentery, jaundice, and liver disorder (Babalola, 1993; James et The presence of these al., 2010). phytochemicals in A. senegalensis can be

attributed to its various medicinal properties as it is being used traditionally (Ruffo *et al.*, 2002). The presence of flavonoids, saponins, and tannins could be attributed to the anti-allergic; antioxidants and anticancer property possess by *A. senegalensis* (Chukwuka *et al.*, 2011; Emmanuel *et al.*, 2005; Ali *et al.*, 2017).

In addition, it was observed the results that crude powder of *A. senegalensis* stem bark recorded lower concentrations of heavy metals (Table 3) than the permissible limit (Table 2), which signified that the extracts are heavy metals toxic free. This finding is similar to the reports of Karayil & Vivek (2014) and Akram *et al.* (2015). Some of these heavy metals, although very toxic at high levels, play some crucial physiological and metabolic roles. For instances, Copper (Cu) deficiency can cause anemia and congenital inabilities (Maobe *et al.*, 2012) while Nickel (Ni) is required by the body in very small quantity for insulin production in the pancreas. Zinc acts as co-factor for over 200 enzymes and functions in different pathway of metabolism (Khan *et al.*, 2013). WHO (1989) and FAO (1996) have documented the permissible limits of most heavy metals (Table 2).

Germination bioassay is the widely used method to determine the phytotoxic activity (Rice, 1984, Putnam & Tang, 1986) and the early seedling growth is the most sensitive stage to evaluate the phytotoxicity (William &Hoagland, 1982; Wardle et al., 1991; Gong et al., 2001). Several indices have been introduced by previous researchers to study the phytotoxic activities of phytotoxic substances on the germination process (WHO, 2005; Maobe et al., 2012). To investigate the phytotoxic potential of A. senegalensis stem bark extracts on germination process, we determined some important germination indices: % seed germination inhibition (%SI), root length (RL), % root length inhibition (%RLI), shoot length (SL), and % shoot length inhibition (%SLI). High significant % seed germination inhibitions were recorded in all extract concentrations used compared to control. However, no significant differences were observed in root and shoot length of germinated seeds in all tested concentrations compared to control while the % RLI and SLI were significantly greater than that of control (Table 3). These signify that crude methanolic extract of A. senegalensis stem bark could be a good source of bioherbicidal. Different weeds are amongst the most key factors responsible for the significant reduction in crops yield (Hussain et al., 2008, Ayaz et al., 2014). To counteract these unwanted weeds, different chemicals are used. However, such chemicals are frequently associated with environmental pollution, residual toxicity, carcinogenesis, high cost and hence their use is restricted (Khuda et al., 2012; Zeb et al., 2014). Consequently, the search for alternative herbicides which are safe and cost-effective is needed. Natural herbicides may be among these alternatives (Anjum and Bajwa, 2005, Ayaz *et al.*, 2014).

The sensitivity of early growth of seedling (% RLI and SLI) to A. senegalensis stem bark extracts as compare to % seed germination inhibition as indicated in Table 3, probably could be due to (1) the presence of seed coat that serves as a barrier between the seed embryo and its environment (Araujo & Monteiro, 2005), (2) the seed coats selective permeability that may prevent the inhibitory activity of phytotoxic extract/substances to penetrate the seed coats (Wierzbicka & Obidzinska, 1998), (3) the protrusion of the root through the seed (parameter used to measure coat germination) which does not necessarily mean growth by cell division (Salvatore et al., 2008).

# Conclusion

Conclusively, the methanolic extract of *A*. *senegalensis* could be relatively not toxic and safe for use in the preparation of medicinal products. The results also indicated that *A*. *senegalensis* stem bark extracts have phytotoxic properties and could contain substances that are phytotoxic. Hence, *A. senegalensis* could be a promising medicinal plant and plant product based natural herbicides.
